First matches begin Friday at 6:00 PM. All Southern California players are required to play on Friday. Determination of status as a Southern California player will be based on your address at the complete discretion of the organizing committee.

Last matches may be played until 8PM pm on Sunday so please arrange your flights accordingly. Due to a very tight schedule, we will not be able to accommodate any time exclusions.

Events: BS, GS, BD, GD, and MX in the following age categories:
U-22 (Born in 1987 or later), U-19 (Born in 1990 or later), U-17 (Born in 1992 or later)
U-15 (Born in 1994 or later), U-13 (Born in 1996 or later), U-11 (Born in 1998 or later)
U-9 (Born in 2000 or later.) **Maximum of 3 events per player (including JITT events)**
(Player's age must be under the age category as of December 31, 2008).

Entry Deadline: March 12, 2008. LATE ENTRIES WILL NOT BE ACCEPTED.

Entry Fees: \$40.00 per person for one to three events. Make checks payable to USBDF. A 10% discount for groups of 15 or more register at same time (ask for form via e-mail). College Students discount is available in exchange for umpiring. **Fee waived for U-9, JITT, and International (non-US) players.**

Eligibility: The 2008 USBDF Spring Junior International Championships is open to all badminton junior players. US players must have USAB membership, can be purchased at the tournament.

Awards: Medals or trophies will be awarded to all winners, runner-ups, semi-finalists, and cons winners.

Conditions:

1. The tournament will be conducted in accordance with applicable BWF and USAB rules.
2. Events may be combined or played round robin format if not enough entries are received.
3. Consolation draws will be held for each event.
4. Up to two Yonex feather shuttlecocks per match will be provided free of charge.
5. All matches will be played in the best 2 of 3 games using the BWF Rally Point Scoring System. Consolation matches may be played in best of one game only (1x21), depending on schedule.
6. A player not ready to play ten minutes after his/her match is called will be defaulted.
7. On court warm-ups is restricted to 3 minutes.
8. The 2007 USBDF and US Junior's National results will be used for seeding arrangement. USAB sanctioned tournaments results may also be used. Adult ranking may be used for U-19 and U-22 events only.
9. Each player in a doubles partnership must submit separate entry forms.
10. Entries will not be refunded if cancelled after March 12, 2008.
11. The Tournament Director reserves the right to change any of the above conditions.
